SUMMARY:

We are looking for engaged, dynamic individuals to join our team as Bilingual Child and Youth Workers. The above casual part-time bilingual positions are located in our North Bay office. Hours of work are not to exceed 24 hours per week with no minimum guarantee of hours. The nature of this position requires flexible working hours, including shift work. Onsite work is required.

Utilizing a framework grounded in trauma informed practice and attachment strategies, the successful incumbents will provide a wide range of hands-on support services to children and families in the child welfare system, resource parents, kin providers and to children and caregivers throughout the community. Duties may include but are not limited to providing one-on-one information and resources to children, families, internal and external professionals on understanding the etiology of children's behaviours and best practices in working to support difficult situations in the home and in the community. All actions are performed according to the vision, mission, values and overall strategic direction of PARNIPCAS. This position is within the Bargaining Unit.

QUALIFICATIONS:

- Child and Youth Worker Diploma
- Consideration will be given to other Social Services qualifications in combination with related experience
- Demonstrated strong communication skills with children and adults
- Ability to incorporate a solid understanding of the impact of early childhood adversity and how it affects individuals' actions and reactions
- Knowledge of various Acts and Legislations, including but not limited to; the Child, Youth and Family Services Act (CYFSA) and flexibility with respect to implementing new policies, practices and Ministry directives
- Sensitivity to and awareness of issues facing First Nations, Inuit and Métis (FNIM) people and the Pathway to Reconciliation
- Recognition of and sensitivity to Anti-Oppression and broad social injustices including, poverty, sexual orientation, race and ethnicity and other forms of discrimination, including disabilities, and their systemic impact on service users, employees, and community as a whole. - Ability and willingness to work flexible hours
