The Clinical Coordinator will report to the Clinical Supervisor of Arbour House, a residential facility for children ages 12-18. The successful incumbent will be responsible for but not limited to assisting with trauma specific diagnostic assessments, therapeutic interventions, direct support services and caregiver engagement for youth and families involve with Arbour House. The incumbent will be familiar with other services and resources in the community and work closely with them to provide information and support when required. All actions are performed according to the vision, mission, values, and overall strategic direction of PARNIPCAS. This position is outside of the Bargaining Unit.
